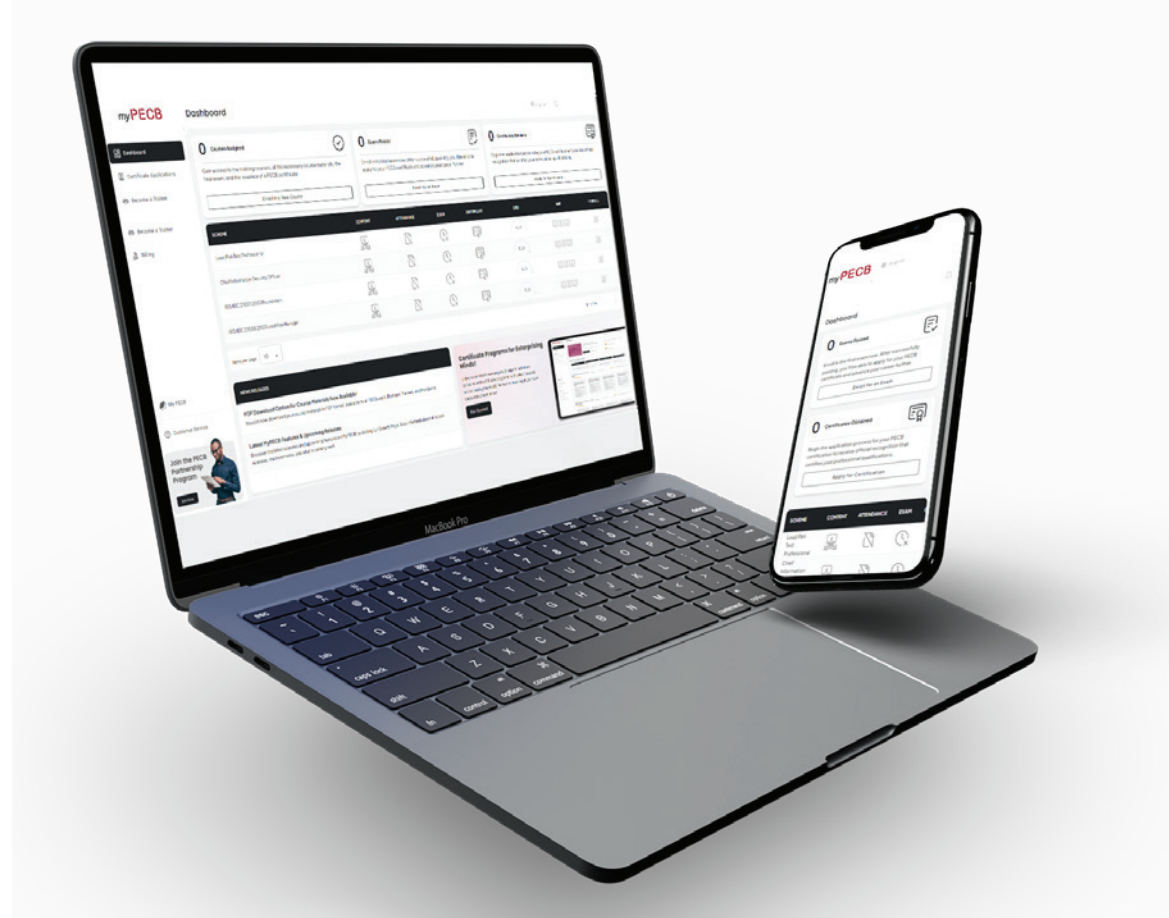
How does the ISO 37001 Lead Implementer eLearning experience look like?
